



2022-2023 Aggregate Verification Worksheet - Dependent Student

Your 2022-2023 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. The law says that before awarding Federal Student Aid, we may ask you to confirm the information you and your parents reported on your FAFSA. To verify that you provided correct information Trinity will compare your FAFSA with the information on this worksheet and with any other required documents. If there are differences, your FAFSA information may need to be corrected. You and at least one parent must complete and sign this worksheet, attach any required documents, and submit the form and other required documents to the Office of Enrollment Services. Trinity may ask for additional information. If you have questions about verification, contact the Office of Enrollment Services as soon as possible so that your financial aid will not be delayed.

Instructions: Complete this section if you, the student, filed or will file a 2020 income tax return with the IRS. The best way to verify income is by using the IRS Data Retrieval Tool (IRS DRT) that is part of FAFSA on the Web at FAFSA.gov. The transcript displays online upon successful completion of the IRS's two-step authentication.
- (3) **Automated telephone Request** by calling (800) 908-9946. Transcript is generally received within 10 business days from the IRS's receipt of the telephone request
- (4) **Paper request Form** – IRS Form 4506T-EZ or IRS Form 4506-T. You will need the address on file with the IRS as shown on 2020 tax return filed. If choosing this option, the tax return transcript must be submitted with this form. Transcript is generally received within 10 business days from the IRS's receipt of the paper request form
